having previously been charged in the case of <u>United States vs. Moving Systems</u>, <u>Inc.</u>, et al., Case No. 03-20139-CR-MARRA, with a violation of Title 18, United States Code, Section 1956(h), that is, conspiracy to commit money laundering, an offense punishable by imprisonment for a term of fifteen years or more, and having been released by the United States District Court for the Southern District of Florida pursuant to Chapter 207 of Title 18, United States Code, did knowingly fail to

appear before said Court as required by the conditions of his release, in that the defendant failed to appear for trial as ordered by the Court on July 11, 2003, in violation of Title 18, United States Code, Sections 3146(a)(1) and 3146(b)(1)(A)(i).
